

Memorandum of Understanding

AND
Central Arkansas Housing Corporation

This Memorandum of Understanding (MOU) establishes an Education and Training Community Outreach Partnership between Shorter College ("SC") and Central Arkansas Housing Corporation (CAHC) to create opportunities for Arkansans to receive a Twenty First (21st) Century education.

Mission

The mission of SC is to provide accessible, affordable and high quality education for students to accomplish their academic or career goals by offering programs that meet the learner's needs in a challenging and nurturing Christian environment.

The mission of CAHC is to serve the residents of Little Rock by developing, owning, and operating safe, decent and affordable housing, while promoting self-sufficiency.

Purpose

In keeping with SC's vision of developing partnerships with the community to create opportunities for students to develop leadership abilities, life skills and to increase their employment potential. SC seeks to partner with CAHC to enhance student access 21st Century Tools and resources in providing education and training to residents.

The partnership will accomplish the above goals by undertaking the following activities:

- Provide on-site recruitment/outreach services within housing facilities
- Work with CAHC and Family Self-Sufficiency Program (FSS) staff to assist with residents attaining their education and training goals.
- Provide access to early college/dual enrollment
- Provide enhanced student support services
- Provide residents with the opportunity to receive education and training
- Prepare students to meet the requirements for career choices
- Prepare students to become self-sufficient and economically independent
- Help students develop proper work habits

Funding

This is a non-financial MOU. SC will be responsible for its own expenses related to this MOU. There will be no funds exchanged between the parties for tasks associated with this MOU.

Duration

This MOU is at-will and may be modified by mutual consent of authorized officials from SC and CAHC. This MOU shall become effective upon signature by the authorized officials from the SC and CAHC and will remain in effect until modified or terminated by any one of the partners by mutual consent with thirty day notice.


Modification, Entire Agreement:
